- Payment terms should be clearly stated and to be after delivery. POSB shall not consider demands for cash upfront unless an advance payment guarantee has been provided by the supplier for amounts above USD\$20,000.00 or equivalent.
- Validity period of quotation to be a minimum of 30 days.

- Bidders must state delivery period from receipt of official order as those with the items in stock will be considered first.
- Bidders must note that if they put more than one option only their main offer will be evaluated.
- Bidders with outstanding orders past their agreed delivery time frames will not be considered.
- Bidders who have failed to fulfill their orders in the past year will not be considered.
- Value added tax must be clearly and separately quoted.

Bidders must also submit the following documents.

- Bidders must attach their CR14 Certificate (List of Directors).
- Bidders must attach their Value Added Tax (VAT) Certificate.
- Bidders must attach their valid ITF263 Tax Clearance Certificate.
- Bidders must attach their valid PRAZ Registration Certificate.
- Bidders must attach their valid NSSA Certificates.
- Bidders must attach a minimum of three (3) authentic, written and signed trade references for similar supplies (mobile phones) dated no more than three years ago.
- Bidders must attach dealership certificates from the OEM for the specific brand they are quoting for.
- **Failure to comply with the terms and conditions set out in this RFQ will lead to automatic disqualification.**
